Exhibitor Terms & Conditions

1. EXHIBITION REQUIREMENTS

- The Exhibitor agrees to attend the Western Sydney Wedding Fair and display relevant products during the specified operating times and dates.
- Products, services, pricing, and promotions are offered directly by participating exhibitors. The organiser is not responsible for the quality, delivery, warranties, or contractual obligations of exhibitors.

2. REGISTRATION

- All attendees must register for a free ticket online prior to entry.
- Admission is granted at the discretion of the event organiser and remains subject to venue capacity.
- Tickets are non-transferable unless otherwise stated.

3. DISPLAY & STAND MAINTENANCE

- All products on display must remain on-site for the full duration of the event unless otherwise agreed.
- Exhibitors are responsible for maintaining their stand area and ensuring compliance with safety regulations.

4. DAMAGE & LIABILITY

- The Exhibitor is responsible for any damage caused to the exhibition venue, equipment, or the organiser's materials.
- The organiser is not responsible for loss, theft, or damage to exhibitors' personal property, except where required by applicable law.

5. STAND CANCELLATION BY ORGANISER

- Western Sydney Wedding Fair reserves the right to cancel an exhibitor's stand prior to the event should circumstances require it.

6. PAYMENT & FEES

- Exhibitors are required to pay the specified site fee plus GST.
- The chosen Exhibitor Package must be paid in full prior to the exhibition. Failure to do so will result in the exhibitor being unable to attend.

7. PROMOTIONS & PRIZES

- Any competitions, giveaways, or prize draws are governed by their own specific promotional terms and conditions.

- Prizes are non-transferable and may not be redeemed for cash unless expressly stated otherwise.

8. EVENT CANCELLATION BY ORGANISER

- Should the organiser need to cancel the exhibition, they reserve the right to postpone or amend the event dates. Exhibitors will be notified accordingly.

9. EXHIBITOR CANCELLATION POLICY

- Should the Exhibitor cancel their participation, a fee of \$200 will be forfeited.
- All payments are non-refundable and non-transferable to alternative dates or venues.
- Cancellations made within 45 days of the expo date will not be entitled to a refund of the full exhibitor fee.

10. ALLOCATION & CHANGES

- The organiser reserves the right to reallocate or relocate an Exhibitor's stand where required due to unforeseen circumstances or operational needs.
- The Exhibitor agrees to accept any such changes and will not be entitled to compensation or make any claim against the organiser as a result.
- Stand space must not be assigned, transferred, or sublet to any other party without the organiser's prior written consent.

11. POWER SUPPLY & SAFETY

- Exhibitors requiring power for their stand must pay a \$50 fee.
- It is the Exhibitor's responsibility to ensure all power extension cords and boards have been tested and tagged by a qualified electrician.

12. TERMS & CONDITIONS

- Western Sydney Wedding Fair reserves the right to update or amend these Terms and Conditions as required.

13. PHOTOGRAPHY & MARKETING

- Photography and videography of the exhibition, including images of exhibitors, may be used for social media, website, and other marketing purposes to promote the event.

14. COMPLIANCE

- Western Sydney Wedding Fair will operate the fair in accordance with advice from relevant authorities.
